- To prevent damage to the unit, operating environment temperature must never exceed 130°F (55°C)
- This unit is equipped with a universal ballast that operates at nominal voltages, 120-230VAC operation
- To Reduce the Risk of Electric Shock DO NOT use in wet or damp locations; this equipment emits UV-C radiation; DO NOT locate equipment in any location allowing direct line-of-sight to vents, returns, or other duct openings



- This unit must be installed by a licensed HVAC contractor or electrician; failure to do so will void warranty of the product
- Unit requires continuous power; we strongly recommend that it is NOT installed where power to the unit will be cycled ON and OFF

- · Live voltage may be present
- Disconnect power at the breaker or fuse panel before servicing unit; always follow OSHA lockout procedures to prevent accidental exposure to electrical energy
- If installed near a furnace or where emergency heat coils could raise the temperature inside the plenum, cycle the AC unit through the heating cycles assuring that the temperature never exceeds 200°F (93°C); the ActivePure\* Cell must not exceed 200°F (93°C)
- When installing, be sure the power to the unit is off; always follow OSHA electrical lockout safety requirements to prevent accidental release of energy during service or maintenance activities
- Never attempt to check operation of the ActivePure\* Cell(s) by direct observation; severe eye damage can result; use the indicator lamps on the bottom of the ballast only



# **INSTALLATION STEPS**




- To Reduce the Risk of Electric Shock DO NOT use in wet or damp locations; this
  equipment emits UV-C radiation; DO NOT locate equipment in any location allowing
  direct line-of-sight to vents, returns, or other duct openings; disconnect from supply
  before servicing or replacing
- This unit must be installed by a licensed HVAC contractor; failure to do so will void warranty of the product



Unit requires continuous power. We strongly recommend that it is **NOT** installed where power to the unit will be cycled **ON** and **OFF**.

1. Remove film from one side of Velcro (2 pieces) and attach to the ActivePure cell as shown.



2. Remove film from opposite side of Velcro.




# **INSTALLATION STEPS (CONTINUED)**

3. Find suitable location for cell, near the center of the coils.


Clean area to remove grease or dirt. Place cell to attach Velcro.

NOTE: Remove cell by separating the Velcro. Press Velcro attached to unit firmly to ensure a good bond.

Replace cell into unit.




4. Connect cell wires to socket of ActivePure Cell Assembly. These wires are a push connection; push until firmly seated. They are not connected when shipped to allow for more options in wire routing.




 The ballast is shipped with the voltage switch, located on the end of the ballast, pre-set to the 230V position. Ensure that the voltage switch, is set to the appropriate position for your application.

NOTE: The 230V setting is for 208 & 230V applications.




6. Attach Velcro to the ballast using same method as above.




# INSTALLATION STEPS (CONTINUED)

7. Mount ballast in suitable location.





8. Connect wiring assemblies to ballast assembly using like colored wires as a guide. (ie; red to red... etc.)





9. Route power wires to the power connection terminals; connect the black wire to the S1 and the white wire to the S2.





10. Dress all wires and replace cover.



## **MAINTENANCE**



To Reduce the Risk of Electric Shock — Disconnect from supply before servicing or replacing.

 Replacing the ActivePure Cell Assembly every (1) one year with a genuine ActivePure part (proof of change required)

Your ActivTek Mini-Split unit requires no periodic maintenance beyond normal replacement of the ActivePure\* Cell Assemblu.



#### WHAT IS COVERED BY THIS WARRANTY

We warrant the ActivTek Mini-Split to the Customer, subject to the conditions below, against defects in workmanship or material, provided that the products are returned to a service location within the following time periods:

- ActivTek Mini-Split within Two (2) years of date of purchase.
- ActivePure Cell Assembly within one (1) year of date of purchase.

### INSTALLATION AND MAINTENANCE REQUIREMENTS
